IMPORTANT NOTICE REGARDING ENTRIES

All entries must be complete, with fees in order to be drawn. **Please submit a separate entry form for each stake entered.** If there are any questions on an entry, you will receive a collect call or an email from the FT Secretary. Include your telephone number and email address on each entry. If entries fill prior to the specified closing date, a waiting list will be established according to postmark received. It is your responsibility to confirm entries with the FT Secretary. **Further, it is each entrant's responsibility to obtain bracing information.**

PRIZES: Plaques will be presented to all 1st place dogs and rosettes to all placed dogs in each stake.

NJ POINTS: NJ Points will be awarded in the Open Gun Dog, Open Limited Gun Dog, Amateur Gun Dog, Amateur Limited Gun Dog, Open Derby, Open Puppy stakes. **PURENA HANDLER OF THE YEAR POINTS will be awarded in the Open Limited Gun Dog-RETRIEVING & Amateur Limited Gun Dog stakes.**

HORSES: Horseback HANDLING and SCOUTING WILL be permitted for all stakes. Walking handling is permitted for all stakes and walking handlers will be braced together when possible. **PLEASE INDICATE IF YOU WILL BE A WALKING HANDLER ON YOUR ENTRY FORM.** Rental horses will be available from Wayne Scubelek (717-264-6476). Handler's horses are not included in entry fee.

STALLS: There are stalls available on a first come basis, at no charge. Let the FT Secretary know which stall you will be using. Once you "reserve" a stall you are responsible for cleaning it out after the trial. If the stall is not cleaned there will be a **\$15.00 cleaning charge.** There is water available at the barn.

CAMPING: There are a few electric outlets on a first come basis, at \$5/day charge. Please keep your area clean.

DIRECTIONS: From the North or South, NJ Turnpike to EXIT 5. Turn RIGHT onto Route #541 after toll. Take Route 541 towards Mt. Holly. Turn RIGHT onto Mt. Holly BY-PASS (at Burger King) towards Route 38. Go straight across Rt. 38 and at next light turn RIGHT onto Route #541. Follow Rt. 541 south through Lumberton towards Medford. Turn RIGHT after the Bob Bende Soccer Park onto dirt drive. Watch for English Setter Club sign and field trial arrows at driveway. Proceed SLOWLY down lane.
