Open Limited Gun Dog and Amateur Gun Dog which will have a CALLBACK RETRIEVE. Shooting to be done by Official Gunners. A blank cartridge WILL NOT be fired in Open Puppy or Amateur Walking Puppy. Quail and/or Chukar and/or Pheasant will be released in all stakes.
