IMPORTANT NOTICE REGARDING ENTRIES

All entries must be complete, with fees in order to be drawn. **Please submit a separate entry form for each stake entered.** Include your telephone number and email address on each entry. If entries fill prior to the specified closing date, a waiting list will be established according to postmark received. It is your responsibility to confirm entries with the FT Secretary. **Further, it is each entrant's responsibility to obtain bracing information.**

PRIZES: Trophies to all first place dogs in each stake. Rosettes to all placed dogs.

NJ POINTS: NJ Points will be awarded in the Open All Age, Open Gun Dog, Open Limited Gun Dog, Amateur Limited Gun Dog, Amateur Gun Dog, Open Puppy, Amateur Walking Puppy and Open Derby.

HORSES: Horseback handling is permitted in all but the designated walking stakes.
Walking in all stakes is welcomed and encouraged
Walking handlers will be braced together if so REQUESTED
There will be no WRANGLER

STALLS: There are stalls available on a first come basis, at no charge. Let the FT Secretary know which stall you will be using. Once you "reserve" a stall you are responsible for cleaning it out after the trial. If the stall is not cleaned there will be a **\$15.00 cleaning charge.** There is water available at the barn.

CAMPING: There are a few electric outlets on a first come basis, at \$10/day charge. Please keep your area clean. **Dumping of sewerage on the property or adjacent to the grounds of the ENGLISH SETTER CLUB will not be tolerated and any offense will be reported to the NJDEP and treated under the full authority of the law.**

DIRECTIONS: From the North or South, NJ Turnpike to EXIT 5. Turn RIGHT onto Route #541 after toll. Take Route 541 towards Mt. Holly. Turn RIGHT onto Mt. Holly BY-PASS (at Burger King) towards Route 38. Go straight across Rt. 38 and at next light turn RIGHT onto Route #541. Follow Rt. 541 south through Lumberton towards Medford. Turn RIGHT after the Bob Bende Soccer Park onto dirt drive. Watch for English Setter Club sign and field trial arrows at driveway. Proceed SLOWLY down lane.
