- All Stakes will be single course without bird field, except Amateur Gun Dog and Open Gun Dog will be **Call Back** bird field with **retrieve**.
- Shooting to be done by Official Gunners. Blaze Orange must be worn by handlers in bird field.
- A blank cartridge will **NOT** be fired in Open Puppy or Amateur Walking Puppy.
- Quail and/or Chukar and/or Pheasant will be released in all stakes.

Standard AKC rosettes to all placed dogs, trophy to first place dog in each stake.
